The Penang Family Health Development Association (FHDA) is an NGO established in 1961 then known as Family Planning Association. We are a not for profit registered society with tax exemption status. We collaborate with the Klinik Kesihatan, Pejabat Kesihatan Daerah and Jabatan Kesihatan Negeri. FHDA is also a partner organisation of the Malaysian AIDS Council. We provide a complementary service for the AIDS programme of the Ministry of Health, Malaysia.

We won the Tun Dr Siti Hasmah Award in 2012 for community work on AIDS. This award is presented by the Malaysian AIDS Foundation.

FHDA depends on funds for projects from donors/sponsors and international or national grants. For administration overheads, advocacy and incubation of new initiatives or charity services we have to raise our own income from public donations and fees for services.

Location

Penang FHDA is located in George Town, in the state of Penang, North West Peninsular Malaysia.

- An office/counseling centre at Jalan Perak, George Town, Penang
- A basic family planning / wellness screening clinic at Kampong Kolam, George Town, Penang.
- A social work centre at Jalan Pegawai, Bukit Mertajam, Seberang Perai Tengah.

The FHDA Programme

1. Clinical (Integrated of Package of Essential Services aka IPES)

FHDA's clinics offer family planning (including Implanon and IUCD insertions), pre and post exposure HIV prophylaxis, medical screening for women's health, HIV, STI and counseling/referrals for all. We have a fortnightly HIV screening/counseling night service - Community Friendly Clinic (CFC).

2. Outreach

- Me and You (MAY) support group for PLHIV with visits to hospitals and MAY4Kids charity aid for children.
- Case management outreach to transgender, street based sex workers and men who
 have sex with men on a STI/HIV harm reduction programme, accompanying the clients
 for medical treatment and follow-up for the clients.
- Outreach to underserved women to provide health-screening services free of charge and referring them to free of charge tertiary care.

3. Counselling

We provide counselling for unwanted pregnancies, relationships and teenage issues.

4. Advocacy

FHDA advocates for policy change to enable increased access to healthcare and employment for marginalized groups. Women's health screening service and education, outreach to places like factories, housing estates, and institutions of education. Comprehensive sexuality education (CSE) is advocated for young people to empower them to learn about family development and awareness of cyber sexual and gender based violence.

5. Aged care

FHDA conducts outreach projects to serve elderly in the community with home visits and activities at old folks' homes.

6. Training

FHDA runs resource person on contraception, sexuality, HIV, STI, SRHR for peer educators, young people, doctors and nurses. We obtained Continuing Professional Development (CPD) Provider status for Malaysian Medical Association and the Ministry of Health. One of our panel is HRDF certified.

7. Publications

- Newsletters and annual reports.

Conclusion

Current challenges are reduction in volunteer enrolment and financial challenges for sustainable income. We welcome volunteers to help us design a sustainable income plan and be involved in projects. We look forward to students from different fields of study who are interested to intern with us.

MESSAGE FROM THE CHAIRMAN

FHDA continued to serve its clients amid the shadows of the Covid-19 pandemic which started in March 2020. During the early days of the lockdown when access to health care was near impossible, we started reaching out to clients by phone and social media. Today, we have formalised this service as Telemedicine. Up to 2020, we have served more than 200 clients, some of whom live outside Penang (e.g. Kedah) and in the ASEAN region.



To alleviate the suffering of those in need during the pandemic, FHDA set up the Covid-19 Relief Fund in 2020. We managed to raise RM43,930 and have provided food aid to 444 eneficiaries. We thank those who have contributed towards this cause and made a difference. This fund is still ongoing.

Among other activities which we have carried out are outlined here. The full report can be found under their respective categories. The first one is a research project in collaboration with three universities - the Centre for Research on Women and Gender, Universiti Sains Malaysia (KANITA); University of Wesminster (UK) and Middlesex University (UK). This project is funded by the Newton Fund Impact Scheme of the British Council (NFIS). The project comprises three interventions viz. training of trainers (TOT), mobile clinic and dissemination of sexual reproductive health (SRH) materials to two factories – Jabil Circuit Inc and Renesas Semiconductor (M) Sdn Bhd. FHDA's component is the TOT.

Next, the UNHCR Outreach programme codenamed CRoSSOVER started late last year and served over 500 refugees mainly the Rohingyas and some Myanmar. The Global Fund grant which started in 2011ends on 30 June 2021. The project is in the process of transition to the Ministry of Health grant for Differentiated HIV Services for Key Population (DHSKP) from 1 Julyto 31 December 2021. FHDA has resubmitted the application and we are glad to note that, at the time of writing, MoH has approved our application for the continuation of the programme.

This year FHDA celebrates its 60th anniversary. Over its 60-year history, FHDA has proven its resilience by overcoming various economic and financial crises to become an NGO that is synonymous with an SRH provider. I feel privileged to present this message as the FHDA chairperson and would like to express my deepest gratitude and appreciation to the past chairpersons and presidents in guiding the organisation over the last 60 years.

Now, as we enter 2021, uncertainties and challenges still abound. One thing is certain, FHDA will continue to be your SRH provider.

I would like to take this opportunity to thank our stakeholders, the governmental bodies, our network partners, staff, volunteers as well as clients for your continued support which has been invaluable to the many successes we have enjoyed to-date. Lastly, we would like to extend our heartfelt thanks to all frontliners (including our staff) who selflessly put themselves at the forefront of the war against the Covid-19 pandemic. Together we will get through the pandemic.


COUNSELLING – A SERVICE IN DIRE NEED ESPECIALLY DURING CRISIS

The lockdown implemented by the government from 2020 impacted different people differently. It does not only change how people work but also changes family life as well. Of course in any crisis, there are those who benefit from the situation to their advantage and sometimes this might beexploitative on the helpless. Counselling becomes essential to allow people to have a safe space to talk about the issues they face to explore their own options and find solutions.

Penang FHDA had served people carrying various burdens seeking help during this difficult hard time. Although not all the cases are directly linked to Covid-19 infection, the crisis brings a great deal of stress. People were less able to cope with their own issues effectively. Despite the closure, Penang FHDA counselling did not close its doors to those in need. Members of the public have various channels to connect to us and usually help is just a call away.

We are now in the midst of MCO 3.0 with no imminent exit in sight although national vaccination has been ramped up.

The past year has been bleak yet blessed. Blessed because we have been reminded of how little we need and how much we already have to be thankful for.

As clinic service is an essential service, it has been a relief to be able to continue keeping clinic sessions open. After the first MCO, our clinic staff learned quickly how to kick into 'MCO mode' the moment subsequent MCOs started.

It was a challenge for clients to attend clinic visits and we had to provide documentation to enable some to cross districts to attend follow up for medicine supply and repeat ultrasounds to monitor problems. In order to help Malaysia contain the spread of Covid, the clinic tried not to schedule

clients without pressing health problems during MCO. This will eventually lead to sub optimal treatment and delay diagnosis of certain conditions - the intangible cost of this pandemic.

Overall, clinic sales and attendance dropped roughly 30-40% for obvious reasons. We are hopeful that Science will save the day.

But vaccines sitting in a vial in the fridge don't work. That is why, we often finish the clinic consultation nowadays enquiring if the client has registered for covid vaccination - our little way of encouraging vaccination and reducing vaccine hesitancy.


Pre & post abortion counselling, contraception education and referrals



One of the aims of contraception is to reduce unintended pregnancy. However, due to inaccessibility of getting contraception during the lockdown; or possibly ignorance and stigma, unintended pregnancies occur. It was reported in 2020 that there were 53 baby dumpings between January and June.

On 8 April 2020 anewborn baby was found outside our premises. FHDA personnel quickly made a police report. The staff also cleaned and dressed him up. We also sought for childless couples to give the child a home. We are happy to report that the child has now been legally adopted and cared for lovingly by his adoptive parents.

Policymakers and the community need to accept this problem with openness and examine the effectiveness of existing programmes and adopt new programmes if old ones fail to work.



STI (Sexually Transmitted Infections) and RTI (Reproductive Tract Infections) information and counselling and laboratory tests

Throughout the year 2020, when the situation of COVID-19 lockdowns were eased, FHDA conducted DHSKP supplemental campaign of free rapid blood tests for Hepatitis C and Syphilis. Kits were provided by the Malaysian AIDS Council and tests were conducted by certified testers.

The goal was to increase uptake of testing under strategy "Getting to Zero" for vulnerable key populations as STI was identified as one of the factors co-existing with HIV. Clients tested reactive were referred and supported to receive treatment by case management officers of the our association. Of 185 screened FSW/ TG sixteen were reactive. 310 men had rapid test and 24 were reactive. They were referred to STI-friendly government health clinics (KlinikKesihatan).

SRH including STI screening using pathological laboratory services forthe refugee community was provided on requestfor women and men. This is part of a community service SRHprogramme supported by the UNHCR. None of those tested and followed up by the medical doctor at FHDA Kampong Kolam required treatment for STI.

FHDA Kampong Kolam as part of the S.O.P. for clients on HIV Pre exposure Prophylaxis (Prep.) therapy and Post Exposure Prophylaxis (Pep.) therapy provided STI screening in addition to HIV screening.


Summarising, a total of 1253 tests were done either as part of a blood screening medical examination package or using rapid test kits. Tests as part of a medical

examination package was comprehensive for STI but those using rapid test kits would be focused only on the test kit used. Regardless of results, all those tested would have received sexual health counselling. Medical follow up was either done at FHDA Kampong Kolam, or, referred to one of the STI-friendly KlinikKesihatan (government health clinic) or private specialist of the client's choice.









Human Immunodeficiency Virus (HIV)

Pre and post-test counselling and HIV tests, risk assessment, treatment adherence, psychological support and referrals

The COVID-19 pandemic has caused widespread loss in terms of lives and infections, a paralysis of social networks and health systems, and economic shutdowns. The movement control order (MCO) in Malaysia started in March 2020. By 2021, we have experienced different kinds of MCOs. These lockdown measures have caused significant disruptions to essential services and supplies, placing immense pressure on our health systems.

For sexual and reproductive health (SRH) services, interruptions in information and service delivery have a serious impact on the health and well-being of people living with HIV. Disruptions in access to healthcare services or medical supplies could result in a lapse of their medication regime which could jeopardise their fight against the virus.




FHDA continue to make our SRH-related services available

to anyone who needs it. We enhanced our online outreach and uploaded more service-related e-posters to disseminate vital information in our social-media. At the same time, we ensured the SOPs were strictly adhered to.

Our assigned online hand-phone number soon produced results. People from all over Malaysia especially states in the northern region wrote in via FHDA's messenger, WhatsApp, WeChat, FB, email and website.

Over and above SRH-related issues, we came across people who asked for food supplies, childcare services and care for the elderly and stroke cases at home. We had made several referrals for these cases. Through donations from generous donors, food supplies were given to those in need.

We were approached by 55 new clients who requested for HIV /AIDS & STI treatment and prevention including PrEP and PEP. A sero-discordant couple holidaying in Pulau Langkawi was stranded in Malaysia and with our help was able to gain access to ARV medication. When they returned to their homeland, they wrote to thank us bearing news about the birth of their second child, a daughter. Inset: their testimony.

In 2021, we firmed up the online outreach as TELEMEDICINE.

Conformation of pregnancy, prenatal care and referral to obstetric care

Prenatal care as part of safe motherhood service under SRH was part of the CROSSoVER Project for refugees. This included laboratory blood tests for prenatal condition, ultrasound check to confirm pregnancy, medical examination by doctor at FHDA Kampong Kolam, then referral for antenatal booking at government health clinic or through Medicins Sans Frontieres (MSF) clinic in Butterworth. Under UNHCR grant, we provided cash based intervention ("Delivery support") to 52 women refugees beneficiaries who delivered babies at government hospitals whereas 86 pregnant women received antenatal hygiene dignity kits with antenatal care milk powder, vitamins and other necessities whereas 80 postnatal women received similar set with vitamin supplements, linen nappies, baby hygiene supplies.



Another approach during recovery MCOwere 13 small group discussions (SGD) for refugees compared to planned six SGD for 82 people.

The topics were:

- Safe motherhood health education
- Breast feeding
- Pregnancy
- Immunization
- Hygiene and Covid-19
- Sexual and gender- based violence (SGBV)









GynaecologyPAP Smear, breast examination, HPV vaccination and referral

The highlight was UNHCR-supported gynaecology/women's health services for refugees from August to December in the year 2020.

Purpose:

- Well women's services to beneficiaries
- · Provide basic treatment on site.

The approach for the women's health services were through:-

· Health camps at the community bases of voluntary key informants such as Rohingya learning centre or home 167 females were seen, including teenage mothers.

- FHDA Kampong Kolam (all seen by Dr. Yim Poh Yin).
- · Referral to the Medicins Sans Frontiere (MSF) clinicin Butterworth.
- Outreach officers sent to other providers such as Klinik Rakyat, KlinikKesihatan, KKIA (Mother and Child Health clinic) or government hospitals.

We targeted 5 health camps - by the end of the project, had organized a total of 10 (ten) health camps. This is a result of good support from the community particularly the women felt comfortable to talk with our team members.

We in FHDA strongly believe in peer education as part of sustain ability effort. We used this opportunity to include abasic assessment tool for gender based violence (GBV) using simple interview questions.

Throughout the CROSSoVER service in 2020, FHDA conducted six (6) peer education trainings for 41 refugees during recovery MCO. These sessions were designed to reach Rohingya community of different socio-demographic groups. Only four people (one male, three female) were assessed as at risk of vulnerable to GBV. One was referred to the UNHCR but no further action was taken when the beneficiary declined to acknowledge her complaint.

In Rohingya culture, patriarchal system is strongly entrenched with little priority on gender and health. These gender awareness sessions rooted in Sexual and Reproductive Health &Rights increased the community awareness of gender based violence.

STAFF AND VOLUNTEER DEVELOPMENT

Project specific objectives:

- 1. Update the administration skills and management knowledge of identified staff and volunteers.
- 2. Orientate newly recruited staff and volunteers vis-à-vis their role, functions and responsibilities.
- 3. Strengthen leadership and governance of volunteers to increase proficiency for the association.

A research project by a collaboration of three universities - the Centre for Research on Women and Gender, Universiti Sains Malaysia (KANITA), University of Wesminster (UK) and Middlesex University (UK) is funded by the Newton Fund Impact Scheme of the British Council (NFIS). The project comprises three interventions viz. training of trainers (TOT), mobile clinic and dissemination of sexual reproductive health (SRH) materials to two factories – Jabil Circuit Inc and Renesas Semiconductor (M) Sdn Bhd. FHDA's component is the TOT.





Due to the Covid-19 pandemic and the government movement control order, the Echo trainings of the project were delayed and rescheduled in May 2021 as online sessions direct to the volunteer workers instead of as peer training. In June 2021, full lockdown was imposed again (MCO 3.0) and the online education also halted temporarily. These are hurdles faced by FHDA trainers, Engie Ng and Chen Fong Theng to complete the training by September 2021.

Report on the Audit of the Financial Statements





NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2020

1. GENERAL INFORMATION

The Penang Family Health Development Association (Persatuan Perkembangan Kesihatan Keluarga Pulau Pinang) (the "Association" or "FHDA") is a voluntary not for profit organisation registered in 1961.

The administration office is located at 333, Jalan Perak, 11600 Jelutong, Pulau Pinang and also houses one of the clinics (FHDA Jalan Perak).

The objectives of the Association are as follows:-

- (a) To promote sexual and reproductive rights as human rights;
- (b) To encourage individuals to take control of their reproductive lives;
- (c) To educate the public on the relationship between population, resources, development, environment and family planning;
- (d) To promote equality between men and women;
- (e) To promote choices in reproductive health;
- (f) To act as the liason body between associate members the Federation of Reproductive Health Associations Malaysia, National Population and Family Development, Ministry of Health and any other agencies interested in reproductive health; and
- (g) To raise funds in furtherance of the above objects.

The Association shall not discriminate on grounds of race, creed, colour, political belief, or sex and provide for a widely based membership.

Its main programme is promoting access to sexual and reproductive health, family health and family development services using four key strategies (01-Advocacy and Champion Rights, 02 - Awareness and Empowerment, 03-Intergrated and Accessible Services and 04-Governance, Management, Development and Sustainable).

Tuanku Ismail Jewa Centre (formerly known as Family Development Centre) launched on 24 October, 2009 in memory of the Association's late past President.

The Association is a member of the Federation of Reproductive Health Associations, Malaysia ("FRHAM").

The principal sources of revenue are project grants channelled through the FRHAM and International Planned Parenthood Federation ("IPPF"), Malaysian Government, Malaysian AIDS Council, ("MAC") Global Fund clinic services.

In order to carry out its task, the Association conducts the following services:-

- (a) Providing clinical reproductive health screening and family wellness services, sexually transmitted infections (STI) clinic, contraception and abortion counselling;
- (b) Supporting HIV/AIDS prevention, screening, treatment adherence and charity supplies rendered to families living with HIV;
- (c) Conducting health information, education and communication campaigns, which cover the underserved and underprivileged communities (such as lower income, elderly, disabled) through outreach mobile clinics and by applying audiovisual materials;
- (d) Empowering young people on sexual and reproductive health and rights to make life choices through youth camps and youth peer activities;
- (e) Improving access to family and sexual health services to marginalised groups and their families. The marginalised groups classified as key populations by the United Nations include sex workers (SW), men who have sex with men (MSM), transgender / transsexual (TG / TS), drug users (DU);
- (f) To implement the programme by hiring staff, maintaining equipment and buildings for the office, centres and clinics at Perak Roads, Kampong Kolam in Georgetown, Jalan Pegawai in Bukit Mertajam, Penang;

(g) Assessing and reporting the effect and conduct of the four strategies undertaken.

The financial statements of the Association are presented in the functional currency, which is the currency of the primary economic environment in which the entity operates. The functional currency of the Association is Ringgit Malaysia as the sales and purchases are mainly denominated in Ringgit Malaysia and receipts from operations are usually retained in Ringgit Malaysia and funds from financing activities are generated in Ringgit Malaysia.

2 SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with the International Planned Parenthood Federation, ("IPPF") accounting policies, Malaysian Private Entities Reporting Standard and the requirements of the Societies Act, 1966 in Malaysia.

The financial statements have been prepared on the historical cost basis, except for the revaluation of certain assets and liabilities.

The principal accounting policies adopted are set out below:

2.1 PROPERTY, PLANT AND EQUIPMENT

The cost of an item of property, plant and equipment is recognised as an asset when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. After recognition as an asset, an item of property, plant and equipment are measured at cost less any accumulated depreciation and any accumulated impairment losses.

Depreciation is provided on a straight-line method so as to write off the depreciable amount of the following assets over their estimated useful lives, as follows:

Depreciation of an asset begins when it is ready for its intended use.

If there is an indication of a significant change in factors affecting the residual value, useful life or asset consumption pattern since the last annual reporting date, the residual values, depreciation method and useful lives of depreciable assets are reviewed, and adjusted prospectively.

The carrying amounts of items of property, plant and equipment are derecognised on disposal or when no future economic benefits are expected from their use or disposal. Any gain or loss arising from the derecognition of items of property, plant and equipment, determined as the difference between the net disposal proceeds, if any, and the carrying amounts of the item, is recognised in profit or loss. Neither the sale proceeds nor any gain on disposal is classified as revenue.

2.2 IMPAIRMENT OF ASSETS, OTHER THAN INVENTORIES AND FINANCIAL ASSETS

The recoverable amount is the higher of an asset's or cash-generating unit's fair value less to sell, value in use and zero.

2.3 Financial assets

Impairment Of Financial Assets

For certain category of financial assets, such as trade receivables, if it is determined that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, the assets are included in a group with similar credit risk characteristics and collectively assessed for impairment.

2.4 Financial liabilities

Financial liabilities are recognised in the statement of financial position when the Association becomes a party to the contractual provisions of the instrument.

On initial recognition, financial liabilities are measured at transaction price, include transaction costs for financial liabilities not measured at fair value through profit or loss, unless the arrangement constitutes, in effect, a financing transaction for the Association to the arrangement.

After initial recognition, financial liabilities are classified into one of three categories: financial liabilities measured at fair value through profit or loss, financial liabilities measured at amortised cost, or loan commitments measured at cost less impairment.

2.5 LEASES

i) Finance Leases

Leases of property, plant and equipment are classified as finance lease where substantially all the risks and benefits incidental to the ownership of the assets, but not the legal ownership, are transferred to the Association.

3. EVENT AFTER THE REPORTING PERIOD

There has been a global pandemic outbreak of Covid-19. The Covid-19 pandemic has had a material adverse effect on the global economy and, specifically, the regional economies in which the Association operates.

On 16 March 2020, the Malaysian Government in response to this threat has announced the imposition of Movement Control Order ("MCO") nationwide to curb the spread of the Covid-19 pandemic in Malaysia pursuant to the Prevention and Control of Infectious Diseases Act 1988 and the Police Act 1987. This MCO was gazetted and effectively means all businesses other than those deemed as essential services were not allowed to operate. The Association therefore has been required to restrict its business activities throughout the duration of the MCO, which resulted in a fall of revenue while having to maintain its overheads.

Before the current financial statements were approved and authorised for issue, the Committee had considered the nature of the impact from the Covid-19 pandemic in Malaysia, that may impact the financial position, financial performance and cash flows of the Association after the reporting date.

The Committee concluded that the impact of non-adjusting events from the outbreak of Covid-19 pandemic does not significantly affects the fair values of the financial assets and non-financial assets of the Association, including the classification of current and non-current items presented on the reporting date. The Committee has indicated their intention to continue in operation.

However, under the Finance Act, 1986 in Malaysia, this exemption had been withdrawn with effect from the financial year ended 31 December 1987 (year of assessment 1988).

11 INCOME TAX (CONT'D)

On 12 January 2021, approval was obtained from the Director of Inland Revenue Board for the Federation and its affiliated members to be exempted from income tax with effect from the Year of Assessment 1988 (year ended 31 December 1987) until the Year of Assessment 2024 (year ended 31 December 2024) under Paragraph 13 Schedule 6 of the Income Tax Act, 1967 (as amended) in Malaysia. Hence, no provision for income tax has been made in the financial statements of the Federation. By virtue of the Association being a member of the Federation, no provision for income tax was made in the financial statement of the Association. This is consistent with the basis adopted in the financial statements of the Federation.

12 AUTHORISATION FOR ISSUE OF THE FINANCIAL STATEMENTS

The financial statements of the Association were authorised for issue by the Committee on 21th May 2021.
